<u>TERMS & CONDITIONS OF HIRE WITH SAFETY INSTRUCTIONS & USER GUIDE FOR</u> <u>DISCO BOUNCY CASTLE</u>

A responsible Adult (18 years old and over) must supervise the Inflatable at all times!

It is the responsibility of the person who is hiring this Inflatable/equipment to ensure that all possible steps are taken to avoid any injury or damage to the Inflatable at all times.

Big on Bouncing Limited cannot accept any responsibility or liability for any accidents, injury or Loss sustained to any person's through the use of our equipment. Big on Bouncing Limited must also warn the hirer that if any accident occurs from the hirers neglect to the supervision then the hirer will be responsible and not Big on Bouncing Limited. It is strongly recommended that the hirer has adequate public liability insurance covering his or her liability arising from the use of the equipment.

Please ensure that the following Safety Instructions are always followed:

- 1) This unit has an age limit of 60 years and a height restriction (as per the user guide below). Please ensure noone over this age or height regulations uses the equipment. Please ensure at all times that the user guide is followed at all times as supplied to you by Big on Bouncing. Please ensure no child/Adults over the guidance for height regulations in the User Guide supplied uses this equipment due to safety and insurance reasons.
- 2) No food, drinks or chewing gum to be allowed on or near the Inflatable which will avoid choking and mess (Please note if the Inflatable is collected in a dirty condition then the person hiring it will incur a cleaning charge of $\pounds 100.00$)
- 3) All shoes, glasses, jewellery, mobile phones, badges **MUST** be removed before using the Inflatable. It is also recommended that spectacles are also removed. No face paints, party poppers, coloured streamers or silly string to be used either on or near the Inflatable. No hosepipes and Washing up liquid are to be used on the Inflatable, this is a serious breach of our Terms & Conditions and can cause a serious injury to those using the equipment. A charge of £100.00 will be invoiced to the hirer if this is found to have happened whilst the equipment is on hire to them.
- 4) No face paints, party poppers, coloured streamers or silly string to be used either on or near the Inflatable.
- 5) No smoking, bonfires or barbeques near the Inflatable.
- 6) Climbing, hanging or sitting on walls is dangerous and must not be allowed. No somersaults are allowed at any time on the Inflatable. There is to be no climbing onto the Shower Covers or walls of the inflatable. This can cause a serious injury.
- 7) A responsible Adult must supervise the Inflatable at all times! The hirer is responsible for the Speaker and Light System, children are not under any circumstances allowed to tamper with them.
- 8) Always ensure that the Inflatable is not overcrowded, and limit numbers according to the age and size of Children/Adults using it, please ensure you follow our user guide as supplied to you. Avoid large and small Children/Adults from using the equipment at the same time.
- 9) Children/Adults are not to push, collide, fight or behave in a manner likely to injure or cause distress to others. Please ensure that Children/Adults are not attempting somersaults and are clothed appropriately and that they have nothing can fall out of their pockets.

- 10) No pets, toys or sharp instruments to be near or on the Inflatable.
- 11) If the Inflatable is not being used for any part of the day, please switch off the blower at the mains.
- 12) Do not allow anyone to bounce off the front safety step as a Child/Adult could easily bounce off the inflatable and get hurt. The step is there is assist users in getting on or off!
- 13) Ensure that no one with a history of back or neck problems, high blood pressure, joint or bone weakness is allowed on the Inflatable as indeed any Child/Adults who is feeling unwell.
- 14) Do not allow anyone to be on the Inflatable during inflation or deflation as this is **DANGEROUS**.
- 15) Ensure that an area of 6 feet (2 metres) around the unit is completely clear.
- 16) The Inflatable should not be used if it becomes wet on the jumping area. If no shower cover is fitted and the event of rain, the unit should not be used.
- 17) In the event of heavy rain or high winds exceeding 38km/h (23.6 mph), Force 5 Beaufort Scale, the unit should be switched off at the mains and deflated immediately and then re-inflated once the winds or heavy rain subside. Beaufort scale description = Fresh Breeze Small trees in leaf begin to sway). Rain water, including bubbling, can be dried off with a towel and the unit can be used again if it stops raining or the wind level falls below that described above.
- 18) In the event that the blower stops working, please ensure all users get off the inflatable immediately. The blower may have a safety reset button, try pressing this, and make sure the blower tube or deflation tube has not come undone or something has not blown onto and is obstructing the blower. In the event that it overheats or loses power, switch the blower off at the mains and then switch it back on again 1 or 2 minutes later, and it should restart. If it does not, inform us immediately. No children should at any time be allowed to be near the electrics or blower of this inflatable, it is the hirer's responsibility to ensure this happens at all times.
- 19) During your hire please ensure the hirer regularly checks all pegs are safely in place.
- 20) If the inflatable is hired late or overnight the castle should not be used in the dark unless there is sufficient lighting to light up the castle.
- 21) Once the equipment has been installed by Big on Bouncing staff, it must not under any circumstances be moved or adjusted at all.
- 22) Overnight hires are an additional cost of £50.00 and subject to availability and conditions. All overnight hires will be collected from 8.00am the following day. We will always require a £100.00 deposit for all overnight hires and two forms of identification, which is fully refundable on collection of the equipment and if the equipment is not damaged and it is as clean as it would have been delivered in. We can only offer overnight hires on our Inflatables to secure gardens, unfortunately we are unable to offer overnight hires in venues. The equipment whilst on hire is the full responsibility and Liability of the hirer. We would also request that the Inflatable is deflated and covered over when you have finished with the castle. We reserve the right on delivery of the Inflatable to refuse to leave the equipment on overnight hire if the area is not secure and safe. If this decision has to be taken there will be no refund given for the hire.
- 23) The hirer shall not use the equipment for any purpose other than described in our Terms and Conditions. The hirer shall not sub-hire or use the equipment or allow the equipment to be used for any unlawful purpose or in any unlawful way.
- 24) If the hirer requires the Bouncy Castle to be switched off during the day, before deflation the speaker must be turned off, unstrapped and removed from the equipment. After the Castle is switched off, firstly unplug the light and then the hirer can remove it from inside the dome. If the Castle is hired overnight it is the full responsibility of the hirer to ensure the Speaker and Light are placed securely indoors. Failure to do this, and if the equipment is damaged or stolen whilst on hire, the hirer will receive an invoice for full payment of the damaged/stolen goods.

Cancellation Policy

With effect from 1st December 2023 once a booking has been made with Big on Bouncing Limited either via telephone, email, via our website, via any of our social media accounts, text message or What's App the following Cancellation Policy will apply to all bookings, as you the hirer have entered into a Contract with Big on Bouncing Limited.

We offer a free of charge cancellation option in the event of heavy rain or high winds if the booking is outside only. Our Free weather cancellation does not cover hot weather. To take advantage of this option the hirer must telephone and email us no later Midday the day before the hire date. At this stage you will be able to rebook your Inflatable for a new date within 6 months of your original hire date, if you decide not to rebook the below cancellation policy will come into effect. If the booking is cancelled for any reason after the time of booking or after Midday the day before the hire date due to weather, the following Cancellation Policy will also be applied:

- Within 8 weeks prior to the event 25% of the order value
- Within 6 weeks prior to the event 50% of the order value
- Within 4 weeks prior to the event 75% of the order value
- Within 2 weeks prior to the event 100% of the order value

In the event of multiple items being booked for the same event and the hirer requests to cancel one or more of these items the cancelled items will be invoiced as per our Cancellation Policy above.

All cancellation Invoices will be sent to the hirer and payment will be required to Big on Bouncing Limited within 7 days of the date of the Invoice.

- 25) Only our delivery personnel are authorized to collect the hired equipment and under no circumstances should any of the equipment be handed over to anyone other than our delivery personnel.
- 26) Hirers are responsible for arranging adequate First Aid cover the event.
