TERMS & CONDITIONS OF HIRE WITH SAFETY INSTRUCTIONS & USER GUIDE FOR SUMO SUITS

A responsible Adult (18 years old and over) must supervise the Equipment at all times!

It is the responsibility of the person who is hiring this Inflatable/equipment to ensure that all possible steps are taken to avoid any injury or damage to the Inflatable at all times.

Big on Bouncing Limited cannot accept any responsibility or liability for any accidents, injury or Loss sustained to any person's through the use of our equipment. Big on Bouncing Limited must also warn the hirer that if any accident occurs from the hirers neglect to the supervision then the hirer will be responsible and not Big on Bouncing Limited. It is strongly recommended that the hirer has adequate public liability insurance covering his or her liability arising from the use of the equipment.

Please ensure that the following Safety Instructions are always followed: Your safety is paramount, in order for you to get the most fun and enjoyment from our equipment please observe these instructions at all times. If there is anything you do not understand or are unsure of please do not hesitate to ask or contact us on the details above.

Please read carefully and sign in the bottom box to signify that you acknowledge and accept these Terms & Conditions and our User Guide supplied to you. The company accepts no responsibility for damage or injury whilst our equipment is on hire to you.

Please ensure the delivery driver has free and easy access to erect the equipment onto a clean flat area. Please be advised that if we arrive and there is insufficient space or the area is unsuitable (e.g.: sloping or is unclean) full payment still has to be made. Big on Bouncing Limited reserve the right to cancel any booking at any time, ie. in the event of bad weather (if more than light shower we may cancel for safety reasons).

- 1. Any damage to any equipment will have to be paid for by the hirer named in our agreement.
- 2. The payment will be the full amount of the cost of the hire of the equipment, either by BACS Pyament no latr than 6pm the night before the hire date or cash payable on the date of hire directly to the delivery person on delivery of our equipment. No equipment will be left without payment. Any deposit requested will be returned at the time of collection providing all the equipment on hire is in a satisfactory condition i.e. no damage to the equipment.
- 3. You ("the hirer") are fully responsible for injury or damage occurred whilst the equipment is on hire and you are strongly advised to take out Public Liability Insurance covering the use of the equipment whilst it is on hire to you.
- 4. We will not be held responsible for any damage caused to any utility services (water mains, ceiling tiles, gas mains, drains or any other underground service, etc.).
- 5. Please ensure there is adequate access to the area of where the equipment is to be sited. If access is to be gained via your house, garage, etc. we cannot be held responsible for any damage caused. Please advise us at time of booking if access may be an issue.

The Hirer is responsible for safe keeping of the equipment and you will be charged for any damage or theft for any items missing from it on its return and fully payment will be required to the value of the goods. **THE HIRER** shall be deemed to have inspected the equipment (and accessories) and to have agrees that it is supplied in good condition unless he/she brings to the attention of Big on Bouncing when it is set up and checked by the hirer when coming into possession of the equipment any faults noted buy the Hirer. The hirer is fully responsible for any equipment that is stolen whilst on hire to them and will be invoiced in full for any replacement equipment that is required.

- 6. You must ensure there is adequate <u>adult supervision at all times</u> when the equipment is in use. The equipment should not be left unattended.
- 7. Shoes must be removed before use of the equipment.
- 8. No Smoking, Bonfires or Barbeques near the equipment.
- 9. Drink, food, chewing gum, pets, sharp objects, large items of jewellery, belts, party poppers, silly string are not allowed on the equipment this will avoid choking and mess equipment returned in a dirty condition will be subject to a cleaning charge of £100.00 per hour.
- 10. No persons who have been face-painted can use the equipment due to the make-up staining equipment. Equipment returned in a dirty condition will be subject to a cleaning charge of £100.00 per hour.

- 11. In the event of rain the equipment should not be used. It is strongly recommended the equipment be dried using a soft cloth i.e. towel, before commencing use.
- 12. Ensure that no-one with a history of neck or back problems is **not** allowed to use the equipment or any person that is feeling unwell or who has had an operation within the last 12 months.
- 13. All equipment is checked on delivery and collection and your signing below indicates acceptance of the equipment as being in good, clean condition.
- 14. Only our delivery personnel are authorized to collect the hired equipment and under no circumstances should any of the equipment be handed over to anyone other than our delivery personnel.
- 15. The Sumo mat must be sited on a level area and at least 2.0 metres away any walls, obstructions and or obstacles.
- 16. Your Sumo package will be supplied with all necessary equipment. Under no circumstances must this equipment be modified, moved, repaired or tampered with in any way. No additional equipment must be added to the Sumo Suits without the written permission of Big on Bouncing Limited.
- 17. We strongly recommend that the area for the Sumo be cordoned off for safety and ease of operation. Fencing or ropes will suffice.
- 18. Adults and children must not use the equipment at the same time. On Adult Sumos Male and Female participants must not compete against each other. Children under the age of 16 may only compete against children of the similar age or size. Only two participants to be on the sumo mat at any time.
- 19. Lay the Sumo suits onto the mat and get the contestants to put them on, children may need some assistance with this. If anybody refuses to wear the required safety equipment, then they cannot wrestle. You are fully responsible as the hirer for both the equipment and the participant. If it is not supervised for any amount of time, then it should be shut down and no one allowed to use it until it can be supervised.
- 20. Before participants commence their bout, ensure that the safety helmet is fastened correctly. Should helmets become loose or dislodged during the joust STOP the participants immediately. Make sure all the protection supplied is being worn; the wrestling mats are not wrestling mats they are Sumo Wrestling Mats, to be used with all of the Sumo Suit equipment and this equipment only. Make sure that the helmet is being worn and is securely fitted onto the user's head; not too tight so as to choke, but it should not be loose or able to move around freely, it should be secure.
- 21. Ensure that spectators DO NOT encroach on the Sumo mat.
- 22. Do not allow participants to punch or kick.
- 23. Do not allow participants to deliver blows to the head.
- 24. Ensure that contestant's stay on the mat. The round is won when your opponent is placed outside the marked ring or is made to fall on his/her front or back. We suggest the best of three rounds.
- 25. On conclusion of the bout remove head gear and suit.
- 26. Before commencing the next bout check that the mats are in the correct position.

Cancellation Policy

With effect from 1st December 2023 once a booking has been made with Big on Bouncing Limited either via telephone, email, via our website, via any of our social media accounts, text message or What's App the following Cancellation Policy will apply to all bookings, as you the hirer have entered into a Contract with Big on Bouncing Limited.

We offer a free of charge cancellation option in the event of heavy rain or high winds if the booking is outside only. Our Free weather cancellation does not cover hot weather. To take advantage of this option the hirer must telephone and email us no later Midday the day before the hire date. At this stage you will be able to rebook your Inflatable for a new date within 6 months of your original hire date, if you decide not to rebook the below cancellation policy will come into effect. If the booking is cancelled for any reason after the time of booking or after Midday the day before the hire date due to weather, the following Cancellation Policy will also be applied:

- Within 8 weeks prior to the event 25% of the order value
- Within 6 weeks prior to the event 50% of the order value
- Within 4 weeks prior to the event 75% of the order value
- Within 2 weeks prior to the event 100% of the order value

In the event of multiple items being booked for the same event and the hirer requests to cancel one or more of these items the cancelled items will be invoiced as per our Cancellation Policy above.

All cancellation Invoices will be sent to the hirer and payment will be required to Big on Bouncing Limited within 7 days of the date of the Invoice.

29.Overnight hires are an additional cost of £50.00 and subject to availability and conditions. All overnight hires will be collected from 7.30am the following day. We will always require a £100.00 deposit for all overnight hires and two forms of identification, which is fully refundable on collection of the equipment and if the equipment is not damaged and it is as clean as it would have been delivered in. We can only offer overnight hires on our Inflatables to secure gardens, unfortunately we are unable to offer overnight hires in venues. The equipment whilst on hire is the full responsibility and Liability of the hirer. We would also request that the Inflatable is deflated and covered over when you have finished with the castle. We reserve the right on delivery of the Inflatable to refuse to leave the equipment on overnight hire if the area is not secure and safe. If this decision has to be taken there will be no refund given for the hire.

30. Hirers are responsible for arranging adequate First Aid cover the event.

ADULT SUPERVISION IS NECESSARY AT ALL TIMES. ONLY 2 ADULTS OR 2 CHILDREN TO FIGHT ON THE MAT AT ONE TIME NO MIXED GROUPS!

Big on Bouncing's staff always carry an accident book. Any accident, however minor, must be entered in the book and signed by both the hirer and Big on Bouncing. If an accident does occur please request the accident book during the collection of the castle and notify Big on Bouncing as soon as possible so a written account of the accident can be recorded.

I acknowledge that I have read and understood this agreement before signing it. I verify that I understand the nature of the activities involved. I will endeavour to ensure that all people using this equipment are physically fit, and able to participate in the event.
